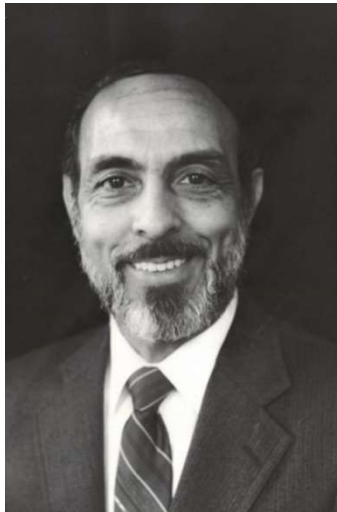

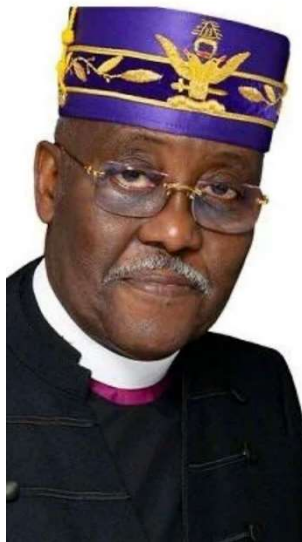

Grand Commander of the United Supreme Council, presided over the ceremony. Ill. Brogdon gave the "Oath of Fealty" and later gave a short dissertation on the Origin of the "Double-Eagle" and then presented S.P. King with his patent for the 32°. The other participants included Ill. William D. Masley, Jr., 33°, Prelate; Ill. William F. Crockett, 33°, Master of Ceremonies, demon-

strated some ritualistic portions; Ill. Ernest Terry, 33°, presented the crown; Ill. Larry Johnson, 33°, Commander-in-Chief, presented the jewel; Ill. Robert B. Oglesby, 33°, read a short dissertation titled "Why Become A Scottish Rite Mason."

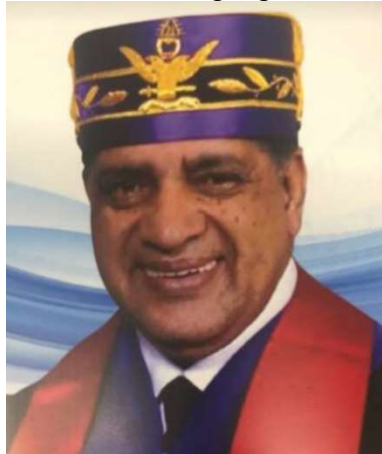
